## Retreat Center Myakka Seawall

Glenn Compton motioned that the Florida Statute 258.501 (7)(a) authorizes the Myakka River Management Coordinating Council to render non-binding advisory opinions to local governments. Sarasota County's Myakka River Protection Code (MRPC): Chapter 54-Environmental and Natural Resources Article XXXIII, which in Section 54-1047 "prohibits construction and development within the 50-foot River Area Buffer or wetlands, "and riverfront landowners are entitled to seek a variance if they meet criteria established by the County. The current variance request advanced by the Diocese of Venice contains 379 feet of buried retaining wall within the Myakka River Buffer Area to address undocumented significant erosion and it contains an exorbitant amount of paving within the Myakka River Protection Zone and consequently, it should be denied to achieve the purposes set out in 54-1047. The prudent approach would be to relocate the drive and then assess the actual rate of erosion before incurring the expense and disturbance of a retaining wall. [Becky Ayech seconded. Sarina Weiss, Howard Berna and Emily Barnett abstained.]

At our most recent (December 13, 2024) meeting, members reflected upon this year's storms: Debby, Helene, and Milton.

This morning (December 26th) the USGS stream gauge on the Myakka near Laurel Road indicated the current water elevation there is now 2.2 feet. During Debby it reached 12.83' and 12.12' during Milton -- so ten feet higher than today.

These storms, and their associated high water events, have generated renewed interest in questioning whether intensive uses should be allowed in areas that both recent photographs and models used by the County and FEMA demonstrate a propensity for flooding.

According the the draft minutes, Bob Clark motioned that the Myakka River Management Coordinating Council write the Sarasota County Board of County Commissioners recommending a pause in consideration of developments within the Myakka River floodplain that would increase the currently allowed building density until such time as the County has undertaken a thorough review of existing standards relating to stormwater management in light of recent catastrophic flooding and the increased severity of weather incidents impacting Sarasota County.

At its most recent meeting (September 20, 2024) Debbie Musallam motioned that the council send letters to the Sarasota County Planning Commission and the Sarasota County Board of Commissioners requesting that they deny the comprehensive plan amendments CPA 2024B & CPA 2024C.

Becky Ayech seconded. Stefan Kaley, Alissa Powers, Howard Berna, Steve Giguere, Jamie Richardson, Bruno Kapacinskas and Emily Barnett abstained.

The following content is from our draft minutes and provides context.

"Nancy Edmondson is a year-round resident of Sarasota County and a great fan of the Myakka River, as she has lived in Venice on North Jackson Road for over 35 years. Two different petitioners are submitting amendments to the comprehensive plan which would allow the conversion of roll properties in south county from OUE1 and OUR to become conservation subdivisions. Potentially the housing density can increase 10 times the current density and roll parts of south Sarasota County. The petitioners are requesting a comp plan amendment to permit conservation subdivisions possessing certain characteristics to be developed with up to two units per acre, pursuant to the transfer of development rights program. Specifically, the petitioners are requesting the addition of the south county area to be included under TDR Policy 2.2, meeting the criteria that the land developed is at least 75 acres. The land is south of the southern terminus of the countryside line. The land is entirely located within 3,000 feet of the urban service boundary. The land is served by Sarasota County's central water and wastewater facilities. There are other sections of the amendment which relate to the north county area and of an area titled Proximity to Economic Development RMA. Her concern is directed toward the potential rezoning of property in the Myakka River floodplain as a conservation subdivision. Concurrently, a rezone petition is being drafted, which is contingent upon the acceptance of this comprehensive plan amendment. The rezone petition targets a property of 100 plus or minus acres on North Jackson Road, which was platted in 1927 as open use rural. It was part of the original dairy in North Venice Farms.

Early on, the land was converted to an agricultural use. What is being proposed by the petitioner is a conversion to conservation subdivision, which instead of supporting livestock will be supporting 200 single family homes. This is a dramatic change from the 17 homes currently zoned for the land. The land is in the Myakka River watershed, Nearly 75% of the land is within the hundred-year flood plain, and 40% of the property is in FEMA zone A. There are potential problems with this specific increase in housing density, 200 homes on these 100 acres, and the infrastructure required to support it threatening the Myakka River. Negative impacts to consider include increases in stormwater, flooding, pollution, and modification to the riverine system. If the CPAs are not accepted, then the rezoning of this property is ineligible as a conservation subdivision.

She asks that the council share their expert opinion on the detrimental impacts of adopting the comp plan amendments to the county planning commission and BCC in a written advisory note."





- To seek necessary action to control and reduce negative impact and growing threats to the park and the river from light pollution, Friends of Myakka River plan to meet with Sarasota County Commissioners to share the attached presentation (shared with the MRMCC on 12/13/24) with their concerns.
- Per feedback from SC staff, Friends of Myakka River plan to request actions necessary for implementing enforceable protections for the park and river as per policies outlined in the UDC and the Sarasota County Comprehensive Plan.

Following her presentation, Stacey Mazza-Gilkison (Friends of Myakka River's council member) motioned that in light of the concerning increase in light pollution at Myakka River State Park and the Wild and Scenic Myakka River Corridor, as illustrated in Friends of Myakka River's presentation to the Council, she moves that the council directs the chair to write a letter supporting Friends of Myakka River's efforts to seek necessary action by the Sarasota County Board of County Commissioners to control and reduce negative impact to the park and the river from light pollution. 

- 704.06 Conservation easements; creation; acquisition; enforcement.—
- (14)(a) Upon application by the fee simple owner of a parcel of land subject to a conservation easement to a water management district, a water management district must release the conservation easement if the following conditions are met:
- 1. The land subject to the easement is less than 15 acres and is bordered on three or more sides by impervious surfaces;
- 2. Any undeveloped adjacent parcels of land are less than 15 acres and similarly bordered on three or more sides by impervious surfaces;
- 3. The land contains no historical, architectural, archeological, or cultural significance; and
- 4. The applicant has secured sufficient mitigation credits using the uniform mitigation assessment method from a mitigation bank located in this state to offset the loss of wetlands located on the land subject to the conservation easement.

# NATIONAL WILD & SCENIC PARTNERSHIP

The Partnership Model works locally with the communities and the federal entity that is a partner with your community is not managing the land. It is managed at the local levels. Under the Partnership Model federal ownership and management are not authorized. There will not be a superintendent at a Partnership Wild and Scenic River. There will not be an arrowhead on the signage. There will not be a park ranger, either. It is locally managed and controlled by a local council with broad representation guides that management just like it is being done now, with all the partners at the table. Land use is locally controlled. The NPS role is limited.

Jamie continued saying there is a fair amount of work to become a Partnership NWSR. What are the advantages? National recognition and prestige are important. There is funding through the Partnership Wild and Scenic River Coalition around the country, up to about \$220,000 per year (per river) through a cooperative agreement that they work with a local nonprofit, and the river and the committee, on dispersing those funds for projects and programs. They are using that funding on the Wekiva for staffing, outreach, stewardship, exotic control, maintenance, and monitoring studies.

Chris offered if we take this course, and if we got in the Partnership Program and received the annual funding. We can grow that funding. The MWSR Program was able to turn \$200,000 to around \$800,000 for the Upper Lake Weir removal by partnering with SWFWMD and FWC. The MWSR Program currently has no direct funding. Money must be pulled from other areas, which is hard especially when he is working outside of MRSP. He must make a big justification. When there are unfunded state park projects, how can I get money outside MRSP? This would be a big financial input from this program.

Mr. Steube (for himself and Mr. Buchanan) introduced the following bill; which was referred to the Committee on Natural Resources

#### A BILL

To amend the Wild and Scenic Rivers Act to designate the portion of the Myakka River lying within Sarasota County, Florida as a component of the National Wild and Scenic Rivers System, and for other purposes.

#### 1. Short title

This Act may be cited as the Myakka Wild and Scenic River Act of 2025.

#### 2. Findings

The Congress finds the following:

(1)

Public Law 95–625 amended section 5 of the Wild and Scenic Rivers Act (16 U.S.C. 1276) to require the study of the Myakka River for potential inclusion in the national wild and scenic rivers system.

**(2)** 

The study determined the Myakka River, was eligible for inclusion in the National Wild and Scenic Rivers System.

(3)

The State of Florida has demonstrated its commitment to protecting this river by the enactment of the Myakka River Wild and Scenic Designation and Protection Act (Florida Statute Chapter 258.501).

(4)

The Florida county of Sarasota and the cities of Venice and North Port have demonstrated their commitment to protect this river in their comprehensive land use plans, local ordinances, and land development regulations.

**(5)** 

The desire for designation of this river as a component of the National Wild and Scenic Rivers System has been demonstrated through strong public support, State and local agency support, and the endorsement of designation by the Myakka River Management Coordinating Council, which represents a broad cross section of State and local agencies, agricultural interests, landowners, environmental, and nonprofit organizations.

(6)

A 12-mile segment of the Myakka River is within the Myakka River State Park with an additional 22-mile segment containing conservation lands held in public ownership or conservation easements within the Myakka River Watershed.

#### SECTION 3.

Designation of Myakka River, Florida, as a component of the National Wild and Scenic Rivers System

(a)

Section 3(a) of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)) is amended by adding at the end the following new paragraph:

(\_\_\_\_) Myakka River, Florida

The 34-mile segments, within Sarasota County referred to in this paragraph, to be administered by the Secretary of the Interior, in partnership with the Myakka River Management Coordinating Council.

Rivers designated under Section 3(a) of the Wild & Scenic Rivers Act, and most designated under Section 2(a)(ii), are classified in one of three categories depending on the extent of development and accessibility along each section. Designated river segments are classified and administered under one of the following, as defined in Section 2(b) of the Wild & Scenic Rivers Act:

Wild River Areas: Those rivers, or sections of rivers, that are free of impoundments and generally inaccessible except by trail, with watersheds or shorelines essentially primitive and waters unpolluted. These represent vestiges of primitive America.

Scenic River Areas: Those rivers, or sections of rivers, that are free of impoundments with shorelines or watersheds still largely primitive and shorelines largely undeveloped, but accessible in places by roads.

Note: These segments are usually more developed than wild and less developed than recreational. This classification may or may not include scenery as an outstandingly remarkable value.


Recreational River Areas: Those rivers or sections of rivers that are readily accessible by road or railroad, that may have some development along their shoreline and that may have undergone some impoundment or diversion in the past.


Note: This classification, however, does not imply that recreation is an outstandingly remarkable value or that the segment must be managed or developed for recreational activities.


#### (b) In general—

The following segments of the Myakka River, within Sarasota County, to be administered in the following classifications:

- (A) The approximately 8.0-mile segment from the Manatee County/Sarasota County line to S.R. 72, as a scenic river.
- (B) The approximately 11.2-mile segment, from S.R. 72 to Laurel Road, as a wild river.
- (C) The approximately 1.9-mile segment, from Laurel Road to Border Road, as a scenic river.
- (D) The approximately 1.5-mile segment, from Border Road to just south of the I-75 Bridge, as a recreational river.
- (E) The approximately 1.5-mile segment, from south of the I-75 Bridge to Snook Haven, as a scenic river.
- (F) The approximately 3.2-mile segment, from Snook Haven to Ramblers Rest, as a wild river.
- (G) The approximately 2.7-mile segment, from Ramblers Rest to U.S. 41, as a scenic river.
- (H) The approximately 4.0-mile segment, from U.S. 41 to the Charlotte County Line, as a scenic river.







Sec 4. Special requirements applicable to Myakka River (a) Definitions In this section and section 5:

#### (1) Myakka river

The term Myakka River means the segments of the Myakka River in the State of Florida designated as components of the National Wild and Scenic Rivers System by paragraph (\_) of section 3(a) of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)), as added by this Act.

#### (2) Council

The term Council means the Myakka River Management Coordinating Council established pursuant to Florida Statute Chapter 258.501.

#### (3) Comprehensive management plan

The terms comprehensive management plan and plan mean the Myakka River Wild and Scenic Management Plan developed by the Council shall be considered to satisfy the requirements for the comprehensive management plan under section 3(d) of the Wild and Scenic Rivers Act (16 U.S.C. 1274(d)).

#### (4) Secretary

The term Secretary means the Secretary of the Interior.

#### (b) Cooperative agreements

#### (1) Use authorized

In order to provide for the long-term protection, preservation, and enhancement of the Myakka River, the Secretary shall coordinate administration responsibilities under this section, and may enter into cooperative agreements pursuant to sections 10(e) and 11(b)(1) of the Wild and Scenic Rivers Act (16 U.S.C. 1281(e), 1282(b)(1)) with the State of Florida Department of Environmental Protection, Division of Recreation and Parks, appropriate local political jurisdictions of the State, the county of Sarasota, City of North Port, City of Venice and appropriate local planning and non-profit organizations.

#### (2) Effect of agreement

Administration of the Myakka River by the Secretary of the Interior through the use of cooperative agreements shall not—

- (A) constitute National Park Service administration of the Myakka River for purposes of section 10(c) of such Act (U.S.C. 1281(c)); or
- (B) cause the Myakka River to be considered a unit of the National Park System.

(3) Publicly owned lands
Nothing in this Act or an agreement under this Act shall affect
the management of publicly or privately owned lands within the
boundaries of the Myakka River watershed by the agencies
having jurisdiction over the lands, in accordance with the
statutory authority of Florida Statute 258.501 and the mission of

(4) Technical assistance and other support The Secretary may provide technical assistance, staff support, and funding to assist in the updating and implementation of the comprehensive management plan.

such agencies.

- (5) Acquisition of land the authority of the Secretary to acquire land for the Myakka River segments shall be limited to acquisition by donation or acquisition with the consent of the owner thereof.
- (6) No condemnation No land or interest in land may be acquired for the Myakka River segments by condemnation.

#### 5. Myakka River Management Council

#### (a) Existing structure

the Secretary shall coordinate the management responsibilities of the Secretary with the Council in the updating and implementation of the comprehensive management plan for the Myakka River.

#### (b) Representative from DOI

The Secretary shall select a representative who shall be added to the Council to represent the National Park Service.

#### (c) Additional members

Other interested parties may be added to the Council, in accordance with the statutory authority under Florida Statute 258.501.

#### (d) Coordination with council

The Secretary shall coordinate the management responsibilities with the Council in the updating and implementation of the Management plan for the Myakka River, to assist the Secretary in carrying out the management responsibilities of the Secretary under this Act.


